Introduction

Real-Time transaction allows you to submit a HIPAA 270 transaction to Wellmark Blue Cross Blue Shield for processing and returning the HIPAA 271 result in real time. Responses are typically returned within 8 seconds. However we suggest you wait at least 100 seconds before closing the request. Only a single transaction can be sent via this method at a time. Thus a single Eligibility Request will get a single Eligibility Response.

Real Time Eligibility is availability 24x7 except for sporadic outages that may occur due to maintenance. Registration

If you are new to submitting electronic transactions to Wellmark and have not registered for a submitter number, you will need to complete the EC Solutions Registration forms. You may download the registration forms located on the provider tab on www.Wellmark.com or call EC Solutions at 800-407-0267. EC Solutions will set up the user's profile in the system and assign a submitter number.

Once there is a submitter number assigned to you, a representative from Wellmark will contact you. Both parties will begin working on the technical requirements to send and receive Real Time transactions.

Requirements

Access to the Real Time Eligibility web service for Wellmark Blue Cross Blue Shield will need to be set up to allow your organization to begin sending transactions. Wellmark will need a contact name, phone number and email address from the organization to have a user ID and password created. Wellmark will contact the organization with the newly created user ID and password.

Once the user ID and password are set up, the user may begin their testing. The web service can be found in a Test region and a Production region. The addresses are as follows:

This service offering requires submitters to adhere to specific communication and message security requirements. To that end, submitters must be able to configure their client application to conduct message level communication using appropriate Transport with Message Credential specifications.

The Web Service has the following method:

Response Result GetEligibility(Request Message)

Input parameter:

- a. Message = An XML message of type Request that contains the HIPAA 270 transaction in the EDI_Data node.

Return parameters:

- a. "Your request timed out. Please resubmit".
- b. "Access denied".
- c. An XML message of type Response that contains the HIPAA 271 transaction in the EDI_Data node.

The following are examples of valid Real Time Transactions Request and Response with properly formatted SOAP envelopes:
