### **The Wellmark Foundation Supports Body Mass Index Surveillance System for Youth**

**(DES MOINES, IOWA)** – A \$64,428 two-year grant from The Wellmark Foundation will allow the Iowa Department of Public Health to begin developing a new body mass index (BMI) surveillance system designed to prevent childhood obesity.

The *Surveillance of Body Mass Index Among Iowa 3<sup>rd</sup> Grade Students* will create and pilot a sustainable statewide system to monitor BMI among Iowa youth, says Catherine Lillehoj, Ph.D., Epidemiologist, Iowa Department of Public Health. “The Bureau of Nutrition and Health Promotion and the Oral Health Bureau will collaborate to measure the height and weight of Iowa’s elementary school children during required oral health screenings,” explains Lillehoj.

According to Lillehoj, dental hygienists conducting oral health screenings will receive training on how to measure and calculate body mass index. This collaboration will allow the bureaus to share resources and work together to support oral health and obesity prevention in youth.

The BMI surveillance system will be piloted with a sample of 1,200 third grade students in 26 elementary schools across the state, which will align with Iowa’s Title V Child Health Center regions. Implementation of the system for all Iowa elementary students is the long-term goal of the project.

The Iowa Department of Education and Title V Maternal and Child Health agencies across Iowa will also collaborate on the project.
