Chiropractic Care

Chiropractic care is designed to treat multiple disorders of the neuromusculoskeletal system, including but not limited to back pain, neck pain, headaches, and pain in joints of legs and arms. It is a hand-on approach to treat subluxation of the spine by manipulation.

Original Medicare

Original Medicare covers the treatment of medically necessary and reasonable chiropractic services specifically by means of manual manipulation of the spine to correct subluxation. The beneficiary must have significant health problem in the form of a neuromuscular-skeletal condition necessitating treatment. The beneficiary's primary diagnosis should be for subluxation of the spine. The precise level of subluxation must be specified by the chiropractor to substantiate a claim for manipulation of the spine.

Original Medicare covers medically necessary chiropractic services related to spinal regions one through five (1-5).

Original Medicare does not cover ultrasound, massage, or x-rays.

Wellmark Advantage Health Plan PPO Enhanced Benefit

Wellmark Advantage Health Plans (WAHP) are Medicare Advantage plans, which provides at least the same level of benefit coverage within a single healthcare plan. This flexibility allows WAHP to offer enriched plans by using Original Medicare as the base program and adding desired benefit options.

Coverage for Enhanced Chiropractic services is provided to members under WAHPs. The scope of the benefit, reimbursement methodology, maximum allowed payment amount and member cost sharing are determined by WAHP.

Reimbursement

WAHP Medicare eligible providers will be paid based on the WAHP Enhanced Benefit Fee Schedule. Providers who are in network with Iowa Chiropractic Physicians Clinic (ICPC) will be reimbursed based on their capitated arrangement. This represents payment in full and providers are not allowed to bill the member for the difference.

Member cost sharing

Cost sharing applies to Wellmark Advantage Health Plan (WAHP) PPO plans and are available In and Out of Network, with potentially higher cost shares when services are performed out of network. Reference the Explanation of Coverage (EOC) or Summary of Benefits (SOB) for specific cost share amounts.

WAHP PPO providers should collect the applicable cost sharing from the member at the time of the service when possible. Cost sharing refers to a flat dollar copayment, percentage, or deductible.

WAHP PPO chiropractic enhanced benefits are in addition to Medicare coverage, and includes routine care of 14 visits per year, one set of diagnostic X-rays (up to three views), approved Evaluation and Management (E&M) and approved physical therapy services.

If the member elects to receive a service that's not covered, he or she is responsible for the entire charge associated with that service.
